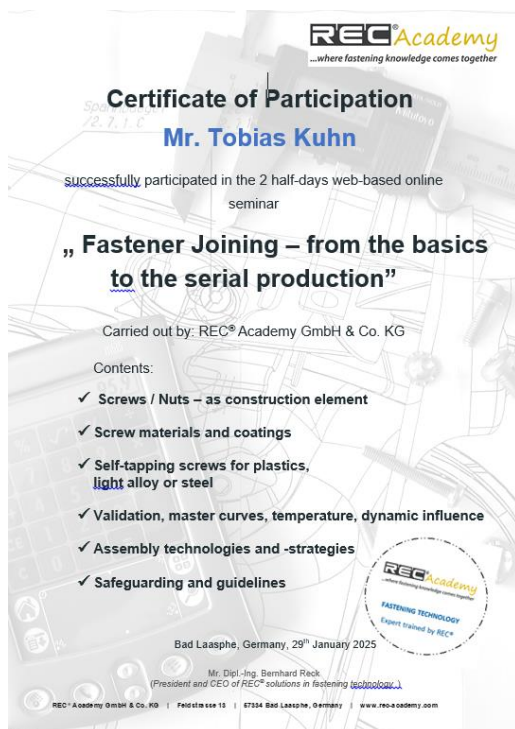
## Background information

Nowadays, the demands on joining technology are becoming constantly higher. More performance with less weight and a small installation space are the most common demands. A further requirement is the efficiency in assembly regarding **process reliability** and **quality**.

A screw connection, which might first be considered as a “minor matter”, can become an absolute disaster in case the screw connection fails. The **image** and **profitability** of a product highly depends on the right screw design.

With the previous considerations in mind, we are offering a seminar, which provides a proper **basis** for carrying out screw design more deliberately and more specifically. The basic principles of bolting technology will be touched from the screw/nut basics till the modern assembly process. Specials like the self-tapping screws or the different loosening protection will be also one of the topics. The participants will be familiar with the most frequently **cited guidelines and standards** and will be more confident and conscious regarding the design of future screw applications.

The WEB seminar will be realized in two parts (part 1 + part 2) on two days. Each session will take approximately 3,5 hours. They build on each other. At the end of the seminar, the participant will perform a multiple choice test. If the exam has been passed with 70% achieved correct answers, you will receive an additional note on the English-language certificate of participation that you have passed the qualification test with success. The certificate of participation will be sent to each participant as a pdf file. The well-passed qualification test serves as an added value for your personal documents, if necessary for submission to the employer and is also suitable for use in the international field.
